

## THE INSPECTION ACADEMY SCHOLARSHIP OFFICIAL RULES

### 1. SPONSOR

### 2. ELIGIBILITY

This scholarship ("Scholarship") is open only to legal residents of the State of Texas who are at least eighteen (18) years of age or older as of the date of entry.
